Action/Decision taken.

In order to ensure that genuine applicants do not suffer on account of decision taken in the earlier meeting it was felt necessary to include an affidavit duly sworn before a Judicial Magistrate as a testimony towards rightful bonafidies of applicants. The statement on the affidavit shall include below averment:

- 1. That the technical qualification has been acquired after physically attending the course of study.
- 2. That the institution holds valid recognition from Pharmacy Council of India.
- 3. That the candidate has simultaneously not been pursuing any other course of study during the period he has remained enrolled as candidate for undergoing the Pharmacy course.
- 4. That in the event of

of the above any averments proved false the Pharmacy Council shall have a right to off strike the registration of the candidate abinitio without providing the candidate any be opportunity to heard. Further, as prudent measure the Council shall initiate correspondence with all such institutions for providing list of passed out candidates along with related admission record of

such candidates.
