Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for re-registration/validation of Pharmacist Registration certificates of all those persons who were registered as Pharmacist under the repealed J&K Pharmacy Act, Samvat, 2011, (1955, A.D);

Whereas, the above exercise was initiated in pursuance to provisio (32C) incorporated in the Pharmacy Act, 1948;

Whereas, an application from your end was uploaded in the Online Portal vide Form reference no: PHAR009087, Dated: 14.01.2021;

Whereas, after scrutiny of uploaded documents following discrepancies was observed;

**"Secondary School Examination (Matric-10th) certificate does not match with the records of J&K Pharmacy Council (now repealed)";**

In light of the contents of foregoing paras and before initiating any action in the matter, you are hereby afforded an opportunity to furnish your response and comments to the undersigned through return mail by or before 07.07.2022 positively;
