**Whereas**, General Administrative Department, J&K vide S.O No. 429, dated 06/09/2022 issued notification and introduced a scheme for making compassionate appointments in the Govt. departments (**Jammu and Kashmir Rehabilitation Assistance Scheme, 2022**);

**Whereas**, the General Administrative department vide circular no- 31-JK (GAD) of 2022, dated: 08.09.2022 issued instructions to Autonomous Bodies, Public Undertakings/Government Companies in U.T of J&K, where SRO 43/1994 is currently in operation to adopt the J&K Rehabilitation Assistance Scheme, 2022 forthwith with the approval of the respective competent authorities namely Governing Bodies, Board of Directors etc;

**Whereas**, above mentioned organizations were also directed to take immediate measures for adoption of J&K Rehabilitation Assistance Scheme, 2022 in respective organizations and set up a dedicated portal for the electronic receipt and disposal of applications for making compassionate appointments under the said scheme;

**Whereas**, the subject policy was discussed in the governing body of the J&K Pharmacy council from time to time under subject reference communications/minutes vide endorsement no's: JKPC-271-284/Estt-1704-

1711, Dated: 09.07.2025 & JKPC-271-284/Estt-2257-2264, Dated: 29.12.2025;

**Whereas,** the Council vide communication/minutes vide endorsement no: JKPC-271-284/Estt-2257-2264, Dated: 29.12.2025, constituted a committee in this regard to prepare a detailed note on the approach/modalities for adoption of J&K Rehabilitation Assistance Scheme, 2022 within the J&K Pharmacy Council;

**Whereas,** the committee vide dated: 03.02.2026 submitted a detailed report and circulated the same among all the Members of the Council for perusal /vetting;

**Whereas,** the Members unanimously agreed to proceed further for adoption of J&K Rehabilitation Assistance Scheme, 2022;

Now therefore, keeping in view the contents of foregoing paras, it is hereby circulated that this Council has decided to adopt the **J&K Rehabilitation Assistance Scheme, 2022 within in the J&K Pharmacy Council** with immediate effect subject to the conditions laid down under the said scheme & adopting any changes/amendments that may follow in due course.
