**Whereas**, the Council staff after scrutiny of response cited above informed that the communication(s) received from Registrar/Examination Controller, Y.B.N University, Ranchi as cited above does not presumably originate from the bonafide source;

**Whereas**, the above inputs were taken on record and as an abundant precaution, an exercise was initiated in a confidential manner with the competent authority of Y.B.N University, Namkum, Ranchi, Jharkhand vide this office communication no: JKPC-Estt/365-372, Dated: 10.07.2023 to unfold the facts surrounding the concerns highlighted above;

**Whereas**, the Registrar, Y.B.N University, Namkum, Ranchi, Jharkhand vide their communication no: YBN/UNIV/R/3023-2024, Dated: 25.11.24 has vehemently



disowned the issuance of communication no: YBN/DPB/180-190, Dated: 29.05.2023 from their side with below remarks:

*"In reference to the above context, it is to bring to your notice that the letter and documents attached with your letter have not been issued by YBN University, Ranchi.*

*In this regard, it is also informed to you that YBN University sends the reply of the verification letter received in favour of its students only through the following official mail, which is given below:*

*Hence you are kindly requested to consider only the verification letter received through the above mentioned university official mail as valid'.*

**Whereas,** followed by the above correspondence, the above inputs were again taken on record and as an abundant precaution, one more communication/exercise was initiated in a confidential manner with the competent authority of Y.B.N University, Namkum, Ranchi, Jharkhand through the above quoted mail vide this office communication no: JKPC-Estt/Verf/1201, Dated: 04.03.2025 to unfold the facts surrounding the concerns highlighted above;

**Whereas,** in response, the Registrar, Y.B.N University, Namkum, Ranchi, Jharkhand vide their communication no: YBN/UNIV/R/4619/2025, Dated: 26.07.25 has again vehemently disowned the issuance of all the communications quoted as above from their side with below remarks:

*"Regarding Verification of Diploma Certificates of Reference, no JKPC/Estt/Verf/1201 dated 04.03.2025:*

*Dear Sir,*

*Regarding the subject mentioned above the university has already informed your good office vide letter no YBN/UNIV/R/3023-2004 dated 25/11/2024 whereby the stand taken by the university has remained the same i.e. the students mentioned in the list are not authentic and genuine students of our university. We have gone thorough verification of the existing data of the students and found that they are not genuine candidates of our university.*

*The enclosure with the application, categorically the letters issued on behalf of the university are fake and not genuine".*

**Whereas,** on the basis of information obtained during the course of investigation, it is now clear beyond any shadow of doubt that the above mentioned applicants have indulged in manipulation & misrepresentation in order to gain a lateral entry into the register of Pharmacists maintained by the J&K Pharmacy Council in the Union Territory of Jammu & Kashmir;





Now therefore, in light of contents of foregoing paras, the applications of all such applicants whose credentials have been disputed by the concerned competent authority i.e Registrar, Y.B.N University, Namkum, Ranchi, Jharkhand vide their communication no: YBN/UNIV/R/4619/2025, Dated: 26.07.25 and applied through the online portal of J&K Pharmacy Council are hereby rejected ab-initio.
