

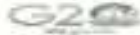

The Council is in receipt of some communications which **casts shadow** on the eligibility of above candidates who claim to have passed from the universities mentioned against their names.

In light of the above, all the Licensing Authorities (Retail/Wholesale) in the Union Territory of J&K are hereby impressed upon not to process any application submitted by the above candidates for grant of Wholesale/Retail license till further orders.

This step is being taken as an abundant precaution to ensure that no person with **dubious/fictitious claims** finds a lateral entry into Pharma business.

In case any of the above persons has obtained Retail/Wholesale license, such license may be disallowed business operation by the concerned Inspector of Drugs / Licensing authorities by invoking provision of Section 22(d) of the Drugs & Cosmetics Act, 1940.
