Subject:	Cancellation/Rejection of registration as Pharmacist of application of Mr. Prince Ahad Mir S/o Mr. Abdul Ahad Mir, R/o Ratnipora, Near Modern Village Gate, Block Kakapora, District- Pulwama (under Section 32 of the Pharmacy Act, 1948-regarding).

Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under the Pharmacy Act, 1948;

Whereas, the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir after the enforcement of J&K Reorganization Act, 2019;

Whereas, an application for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948 from your end was uploaded in the Online portal vide Form reference number **PHAR017333, Dated: 10.03.2026** along with requisite documents as prescribed under the Checklist;

Whereas, a matter of practice and procedure, the eligibility certificate uploaded from the applicants end was referred to the concerned university/examining body for purpose of verifying as genuineness;

Whereas, the Competent Authority, i.e. Assistant Registrar, I.K.Gujral Punjab Technical University, Jalandhar communication no: **IKGPTU/2026/REG/COE/AR/7, Dated: 27.03.2026** vehemently disowned the issuance of Bachelor of Pharmacy certificate from their side and therefore suggesting that the same has been treated as fake with the following remarks:

"This is certified that the Education of following student is not consistent with University record and has not been issued by the I.K.Gujral Punjab Technical University, Jalandhar. This document is not verified with the record of the University."

Whereas, the response highlighted herein above clearly indicates that the claim of eligibility by the applicant are not bonafide & further the said person has indulged in unfair means;

Whereas, at the time of filing the application through online portal, the applicant has also submitted an affidavit duly sworn before Sub-Judge Special Mobile Magistrate , Pulwama with one of the below averments:

"That in the event, my eligibility for registration as Pharmacist is found to have been acquired through misrepresentation, impersonation or concealment of material facts and found false, the Pharmacy Council shall have a right to strike off my registration as Pharmacist ab-initio without providing me any opportunity for being heard".

Whereas, the above person was offered an opportunity to provide his response in the matter through show cause notice vide this office letter bearing no: JKPC/SCN/2026/PHAR017333/2518-2525, Dated: 17.04.2026;

Whereas, reply via mail dated: 17.04.026 from the applicant's side through text mail has been examined and found devoid of any merit;

Now, therefore the undersigned in exercise of powers vested under the Pharmacy Act, 1948 rejects the application of the applicant for registration as Pharmacist with immediate effect.

(The above action is being taken in pursuance to the communication forwarded by the I.K.Gujral Punjab Technical University, Jalandhar reflected at para supra (Inter-alia disputing your eligibility claims for registration as Pharmacist).
