Whereas, a communication purported to have been originating from "Veer Bahadur Singh Purvanchal University, Jaunpur, U.P vide no: VBSPU-2024/204242/1772, Dated: 25.11.2024, list/record/verification of some applicants was received through mail ID: registrarvbspu.in@gmail.com;

Whereas, the Council staff after scrutiny of response cited above informed that the communication (List/Record/verification) received from" Veer Bahadur Singh Purvanchal University, Jaunpur, U.P "as cited above presumably not originating from the bonafide source;

Whereas, the above inputs were taken on record and as an abundant precaution an exercise was initiated in a confidential manner with the competent authority of Veer Bahadur Singh Purvanchal University, Jaunpur, U.P through mail to unfold the facts surrounding the concerns highlighted above;

Whereas, during the course of confidential verification, the Head, Institute of Pharmacy, Veer Bahadur Singh Purvanchal University, Jaunpur, U.P vide their communication/trailing mail dated: 19.02.2025 & VBS University, HOD, letter no:- Memo/verf/2025, Dated: 20.02.2025 has vehemently disowned the issuance of record submitted vide communication no: VBSPU-2024/204242/1772, Dated: 25.11.2024 from their side with the following remarks:




"Thank you for your communication dated 18/02/2025 regarding the verification of candidates applying for registration as pharmacists from the Union Territory of Jammu & Kashmir. After thoroughly reviewing our records, we would like to inform you that, to date, no candidate from the Union Territory of Jammu & Kashmir has either been admitted to or has passed the B. Pharm or D. Pharm

programs at our institution. As such, we do not have any relevant records to submit in response to your request".

Whereas, on the basis of information obtained during investigation, it is now clear beyond any shadow of doubt that the above mentioned applicants have indulged in manipulation & misrepresentation in order to gain a lateral entry into the register of Pharmacists maintained by the J&K Pharmacy Council in the Union Territory of Jammu & Kashmir;

Now therefore, in light of contents of foregoing paras, the applications of all the above applicants whose credentials have been disputed by the concerned competent authority of the university are hereby rejected ab-initio.
