**Whereas,** the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under the Pharmacy Act, 1948;

**Whereas,** the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir after the enforcement of J&K re-organization Act, 2019 ;

**Whereas,** an application for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948 from your end was uploaded in the Online Portal vide Form reference no: PHAR000207, Dated:- 17.12.2020 along with the documents as prescribed under the checklist;

Whereas, the application submitted as above was approved & the registration as Pharmacist was granted in your favour as per below details in view of the fact that you claimed to hold a degree in Pharmacy from Veer Bahadur Singh Purvanchal University, Jaunpur, U.P;

**Whereas,** the above inputs were taken on record and a confidential exercise was initiated with the competent authority of Veer Bahadur Singh Purvanchal

**Whereas**, in response to the above mail a return mail/communication from Head, Institute of Pharmacy, VBSPU, Jaunpur, U.P was received, vide letter no: MEMO/Verf/2025, Dated: 20.02.2025, the operative para of which is reproduced as under:

**"Thank you for your communication dated 18/02/2025 regarding the verification of candidates applying for registration as pharmacists from the Union Territory of Jammu & Kashmir. After thoroughly reviewing our records, we would like to inform you that, to date, no candidate from the Union Territory of Jammu & Kashmir has either been admitted to or has passed the B. Pharm or D. Pharm programs at our institution. As such, we do not have any relevant records to submit in response to your request".**

**Whereas**, the above chronology of events clearly indicates that you have indulged in unfair means and submitted fictitious documents by resorting to manipulation and misrepresentation/impersonation;

In light of the contents of foregoing paras, the application submitted by you stands rejected ab-initio in terms of reference order dated: 21.02.25. However before your name is struck off from the register maintained by the J&K Pharmacy Council, you are hereby afforded an opportunity to furnish your response and comments in the matter in writing to the undersigned through return mail by or before **28.02.2025** positively;

It may be noted that in the event of your failure to respond to this notice, the Council shall be constrained to initiate ex-parte action against you.
