Whereas, on the basis of information accessed during investigation, it has now become amply clear that the above mentioned applicants have indulged in manipulation & misrepresentation in order to seek a lateral entry into the register of Pharmacists maintained by the J&K Pharmacy Council in the Union Territory of Jammu & Kashmir;

In light of contents of foregoing paras, the applications of all such applicants whose credentials have been disputed by the concerned competent authority by the university and also those candidates who had applied through online portal on the basis of claiming to have acquired the requisite eligibility from the above university namely " Bundelkhand University" are hereby rejected ab-initio.
