Whereas, the above exercise was initiated in pursuance to provisio (32C) incorporated in the Pharmacy Act, 1948;

Whereas, an application from your end was uploaded in the Online Portal vide Form reference no: PHAR004774, Dated: 28.12.2020;

Whereas, after scrutiny of uploaded documents following discrepancies was observed;

**"Secondary School Examination (Matric-10th) certificate does not match with the records of J&K Pharmacy Council (now repealed)";**
