Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under the Pharmacy Act, 1948;

Whereas, the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir after the enforcement of J&K re-organization Act, 2019 ;

Whereas, an application for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948 from your end was uploaded in the Online Portal vide Form reference no: PHAR0: 03152 , Dated: 29/04/2021. along with below documents (Whichever is applicable):

Whereas, as a matter of practice & procedure, the eligibility certificate uploaded from your end was referred to the concerned university/examining body for purpose of verifying its genuineness;

Whereas, a communication presumably originating from :MU/VER/2022-23/134 dt:22/03/2023 was received by the J&K Pharmacy Council on 05/04/2023, which was taken on record & the application submitted by you was approved & the registration as Pharmacist was granted in your favour as per below details:

Whereas, the staff dealing with applications uploaded through online portal informed that there is some evident suspicion about the credentials of applicants who claim to have obtained requisite eligibility from Monad University;

Whereas, the above inputs were taken on record and a confidential exercise was initiated with the competent authority of Monad University (Registrar & Director Administration) who provided the email ID wherein all the details mentioned in the forgoing paras was shared with the said competent authority on mail;

Whereas, in response to the above mail a return mail was received, the operative para of which is reproduced as under:

"This is with reference to your letter no. JKPC-Estt/211-218 dated 03 July, 2023. It is intimated that letter no. MU/VER/20222-23/134 dated 22 Mar 2023 has not been forwarded by the university. The above information is as per the record available in the university."

Whereas, the above chronology of events clearly indicates that you have indulged in unfair means and submitted fictitious documents by resorting to manipulation and misrepresentation/impersonation;

In light of the contents of foregoing paras and before taking any final action in the matter, you are hereby afforded an opportunity to furnish your response and comments in the matter in writing to the undersigned through return mail by or before 15 days positively;

It may be noted that in the event of your failure to respond to this notice, the Council shall be constrained to initiate ex-parte action against you.
