Subject →	Cancellation/Rejection of registration application of Mr. Sameem Sultan S/o Mr. Dr. Mohammad Sultan R/o Near Jama Masjid, Sharief Molana, Azad road, District- Srinagar (under 32 of the Pharmacy Act, 1948-regarding).

**Whereas**, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under the Pharmacy Act, 1948;

**Whereas**, the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir after the enforcement of J&K re-organization Act, 2019;

**Whereas**, an application for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948 from your end was uploaded in the Online Portal vide Form reference no: PHAR009995, Dated:- 10.01.2023 along with the documents as prescribed under the checklist;

**Whereas**, as a matter of practice & procedure, the eligibility certificate uploaded from your end was referred to the concerned university/examining body for purpose of verifying its genuineness;

**Whereas**, a communication presumably originating from Veer Bahadur Singh Purvanchal University, Jaunpur, U.P was received by the J&K Pharmacy Council on 15.02.2023 which was taken on record & the application submitted by you was approved & the registration as Pharmacist was granted in your favour as per below details:

**Whereas**, the staff dealing with applications uploaded through online portal informed that there is some evident suspicion about the credentials of applicant who claims to acquired requisite eligibility from Veer Bahadur Singh Purvanchal University, Jaunpur, U.P;

**Whereas**, the above inputs were taken on record and a confidential exercise was initiated with the competent authority of Veer Bahadur Singh Purvanchal University, Jaunpur, U.P through E-mail along with all the documents uploaded as per checklist;

**Whereas**, in response to the above mail a return mail/communication from Head, Institute of Pharmacy, VBSPU, Jaunpur, U.P was received, vide letter no: MEMO/Verf/2025, Dated: 20.02.2025, the operative para of which is reproduced as under:

"Thank you for your communication dated 18/02/2025 regarding the verification of candidates applying for registration as pharmacists from the Union Territory of Jammu & Kashmir. After thoroughly reviewing our records, we would like to inform you that, to date, no candidate from the Union Territory of Jammu & Kashmir has either been admitted to or has passed the B. Pharm or D. Pharm programs at our institution. As such, we do not have any relevant records to submit in response to your request".

Whereas, the response highlighted herein above clearly indicates that the claims of eligibility by the applicant are not bonafide & further the said person has indulged in unfair means;

Whereas, at the time of filing the application through online portal, the applicant has also submitted E-undertaking with one of the below averments:


*"That I am fully aware that in the event of any of my document found invalid, fake or false as also for any concealment or misrepresentation of facts stated herein, the J&K Pharmacy Council has the power to delete/reject my candidature as Registered Pharmacist without any formal notice or information".*

Whereas, the above person was offered an opportunity to provide his response in the matter through show cause notice vide this office letter bearing no: JKPC/SCN/2025/PHAR009995-Estt-1025-1039, Dated: 21.02.2025;

Whereas, till date no reply was received from the applicants end;

Whereas, the applicant has failed to respond to the communications reflected in para supras and therefore the applicant has not availed of his right to be heard before a decision in the matter is taken.

Now, therefore the undersigned in exercise of powers vested under Section (36) of the Pharmacy Act, 1948 rejects the application of the applicant for registration as Pharmacist in terms of Section 32 of the Pharmacy Act, 1948 and the name of the applicant is hereby removed from the register maintained by the J&K Pharmacy Council with immediate effect.
