Whereas, during the course of confidential verification, the Controller of Examination, J&K Nursing Council/Erstwhile Paramedical Council, GMC, Srinagar vide their communication no: SPMC/GMC/SGR/5069-70, Dated: 28.02.2025 has vehemently disowned the issuance of above certificates in favour of quoted applicants from their side with the following remarks:

"Refer your letter no: JKPC-Estt/Verf/1093-1094, Dated: 24.02.2025. In this connection, the requisite information regarding verification of Medical Assistant/Pharmacist sought by your office is checked by the office of the undersigned and has been found Fake/Fabricated as per the records available in this office and the below mentioned particulars of the diploma certificates have been tempered by the concerned applicants"

Whereas, on the basis of verification reply furnished by the examining authority, i.e, J&K Nursing Council/Erstwhile Paramedical Council, GMC, Srinagar, it has been established that the above mentioned applicants have indulged in manipulation & misrepresentation in order to gain a lateral entry into the register of Pharmacists maintained by the J&K Pharmacy Council in the Union Territory of Jammu & Kashmir;

Now therefore, in light of contents of foregoing paras, the applications of all the above applicants whose credentials have been disowned by the said competent authority are hereby rejected ab-initio.
