Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no:JKPC-86/Estt/681-91, Dated: 16.12.2020 & JKPC-284-Estt-793-807, Dated: 28.08.2023 inviting therein applications for re-registration/validation of Pharmacist Registration certificates of all those persons who were registered as Pharmacist under the repealed J&K Pharmacy Act, Samvat, 2011, (1955, A.D);

Whereas, the above exercise was initiated in pursuance to provisio (32C) incorporated in the Pharmacy Act, 1948;

Whereas, an application from Mr. **Ferooz Ahmad Bhat S/o Mr. Mohmad Sultan Bhat R/o Sherpora Balla, District-Anantnag-Kashmir** was uploaded in the Online Portal vide Form reference no: **PHAR023473**;

Whereas, after perusal of office records/scrutiny of uploaded documents following discrepancies were observed;

- (a). **That the registration number: "9875" mentioned in the uploaded certificate actually belongs to Shri Rajesh Kumar Kalha S/o Shri Suraj Parkash Kalha R/o 29-A, Jain Bazar, Jammu**";


Whereas, the observations highlighted herein above suggests that the registration as Pharmacist as uploaded by Mr. **Ferooz Ahmad Bhat S/o Mr. Mohmad Sultan Bhat R/o Sherpora Balla, District-Anantnag-Kashmir** is not issued by the competent authority;

Whereas, Mr. **Ferooz Ahmad Bhat S/o Mr. Mohmad Sultan Bhat R/o Sherpora Balla, District-Anantnag-Kashmir** was offered an opportunity to provide his response in the matter to a show cause notice served upon the

said person vide this office letter bearing no: JKPC/SCN/2023/PHAR023473-1486-1501, Dated: 04.12.23;

**Whereas,** reply received from the applicants side through mail dated: 06.12.23 was examined and found devoid of merit;

**Now, therefore the undersigned in exercise of powers vested under the Pharmacy Act, 1948 rejects the claims of the applicant for re-registration as Pharmacist in terms of Section 32C of the Pharmacy Act, 1948, on the ground that no such certificate has been issued/ granted by the J&K Pharmacy council under the repealed J&K Pharmacy Act, Samvat, 2011.**
