Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under the Pharmacy Act, 1948;

Whereas, the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir following enforcement of J&K Reorganization Act, 2019;

Whereas, applications from below mentioned applicants were uploaded in the online portal as identified along with necessary documents (prescribed under the Checklist) for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948;

Whereas, the above inputs were taken on record and as an abundant precaution, an exercise was initiated in a confidential manner with the competent authority of Ch. Charan Singh University, Meerut, U.P through mail to unfold the facts surrounding the concerns highlighted above;


Whereas, the Vigilance Officer, Ch. Charan Singh University, Meerut, U.P vide their communication/mail Dated: 06.10.2023 has vehemently disowned the issuance of record submitted Dated: 05.06.2023 from their side in respect of following 20 applicants;

In light of contents of foregoing paras, the applications of all such applicants whose credentials have been disputed by the concerned competent authority by the university and also those candidates who had applied through online portal on the basis of claiming to have acquired the requisite eligibility from the above university namely " Ch. Charan Singh University, Meerut, U.P" are hereby rejected ab-initio.
