Whereas, the Council staff after scrutiny of response cited above informed that the communication received from "Mahamaya Technical University, Noida" as cited above presumably not originating from the bonafide source;

Whereas, the above inputs were taken on record and as an abundant precaution an exercise was initiated in a confidential manner w.r.t physical verification of records to unfold the facts surrounding the concerns highlighted above;


Whereas, during the course of physical verification, an extensive survey was carried out to locate the said university namely M/s "Mahamaya Technical University, Noida" as per the address available on its website i.e Sector- 62 & Sector - 110 of Noida particularly in and around Block B, Industrial Area, Sector, 62, Noida & Maharishi Nagar Entry Gate no; 4, Opposite Sector-110, Noida;

Whereas, as on the address given above M/s "Maharishi University" exists but no such entity/institution/university under the name and style of M/s "Mahamaya Technical University, Noida" exists physically at the above address;

Whereas, the matter was further enquired from the local residents, staff of "Maharishi University" and it was given to understand that no entity actually in the name of M/s "Mahamaya Technical University, Noida" exists at the said place/area;

Whereas, on the basis of information accessed during investigation, it has now become amply clear that the above mentioned applicants have indulged in manipulation & misrepresentation in order to seek a lateral entry into the register of Pharmacists maintained by the J&K Pharmacy Council in the Union Territory of Jammu & Kashmir;

In light of contents of foregoing paras, the applications of all such applicants whose credentials have been disputed and also those candidates who had applied through online portal on the basis of claiming to have acquired the requisite eligibility from the above university namely "Mahamaya Technical University, Noida" are hereby rejected ab-initio.
